1.	Pharmaceutical products 300490, 300390, 300420, 300432	Algeria imports substantial amount of pharmaceutical products. Algeria imported US\$ 2 billion of pharmaceutical products in 2019 among which US\$ 9 million were imported from India in 2019.		
2.	Chickpeas 071320	Chickpeas represented an import of US\$ 44 million by Algeria from India in 2019. This wide consumer product is imported by Algeria in big quantities. The total imports of chickpeas by Algeria in 2018 were US\$ 103 million. Chickpeas are mainly imported from Canada, USA, Mexico, India, Turkey and Russia and are largely consumed during Ramadan period. In 2019, the imports of pulses including chickpeas by Algeria reached US\$ 239 million.		
3.	Semi whitened rice and paraboiled rice 100630	 Algeria does not produce rice, so this product is 100% imported. It imports about 100,000 tons annually, mainly from India, Vietnam, Thailand, Pakistan, Tajikistan,Uruguay, Argentina and Spain. This market is still promising for rice because of its popularity among local people. On the other hand, the number of Asian workers in Algeria also continues to increase, which helps to increase the demand. Algeria's imports of rice reached US\$ 87 million in 2018 among which US\$ 38 million were imported from India in 2018 and US\$ 37 million in 2019. 		
4.	Shelled grinded peanuts 120242	Algeria imported peanuts worth US\$ 239 million in 2019. It imported from India the amount of US\$ 3 million in 2019. Dried fruits are mainly imported in bulk and packed in Algeria.		

5.	Polyethylene terephtalate 390761	Algeria's imports from India reached US\$ 10 million in 2019. Algeria's total imports of these products during the same period reached US\$ 30 million in 2019. This product is imported for its use for packaging foods and beverages, especially convenience-sized soft drinks, juices and water. Algeria is the largest importer of plastic and packaging technologies on the African continent.
6.	Granites 251612	Algeria's total imports of granite reached US\$ 300 million in 2019. Algeria' imports from India was US\$ 20 million in 2019. Algeria used to produce up to 30 000 tons of marble and granite and it is today producing only 14 000 tons.
7.	Medical equipment and disposables 901839	Algeria's medical equipment import volume over the past five years is US\$ 4 billion. Algeria's imports of needles, catheters used in medical, surgical, dental or veterinary sciences from India in 2019 reached US\$ 6 million.

	Trade in Goods	 Industrial equipment goods, which represented nearly 32% of the structure of imports decreased by 31.52%. Semi-finished product group decreased by 31.51% Food products imports decreased by 3.50%. Consumer goods (non-food) decreased by 6.81%. Italy was the main customer of Algeria and China its 1st supplier during January to February 2020. 	Algeria's economy is going through a difficult time due to the recent collapse in oil prices caused by the outbreak of COVID-19. Algeria is very dependent on hydrocarbon revenues and its has a low diversified economy. Hydrocarbons sales represent around 92 % of the global value of exports. From January to February Algerian exports dropped by 27.89%. They reached US\$ 4.9 billion against US\$ 6.795 billion in the same period in 2019. The drop in the world oil market should reduce Algeria's exports for the current year by 7.5%. According to the Algerian government, the country's foreign exchange reserves will drop to US\$ 44.2 billion by the end of 2020, which is equivalent to one year of imports. This will lead Algeria to reduce even more its dependence on imports.
